Financial bid on plain paper in sealed covers are invited by the undersigned for disposal of five Luna Mopeds and one Hero Honda Splendor Motor Cycle bearing Regd. Nos. (1). OR-02A-3210, (2).OR-02A-3833, (3). OR-02-AN-1932, (4). OR-02-BM-3802, (5). OR-02-BM-3650 and OR-02D-0848 respectively of Raj Bhavan, Bhubaneswar.

2. The intending bidders may inspect these vehicles at Raj Bhavan Garage inside the Raj Bhavan premises on any working day during office hours between 11.00 A.M. to 4.00 P.M. before submitting the bids. Each bidder has to deposit the earnest money of Rs.500/- (Rupees five hundred) only for each vehicle ( total for Rs.3,000/- for six vehicles) in shape of cash with Under Secretary to the Governor (Finance) to participate in the auction, which will be refunded to the unsuccessful bidders.

3. The bidders are to submit the financial bids in a closed cover and deposit the same at the Reception Office of Governor's Secretariat, Raj Bhavan, Bhubaneswar on or before 18.05.2022 up to 12.00 noon from the date of issue of this Notice. All the bids received shall be opened by the Under Secretary (Finance) to the Governor at Raj Bhavan Garage at 4.00 p.m. on 18.05.2022 in presence of the bidders or their authorized agents. If this day is latter declared as a Government holiday then the bids will be received and opened on the next working day as per the scheduled time.

4. The highest bidder whose bid is accepted, shall immediately deposit 25% of the offered amount as initial deposit. She / He shall deposit the balance amount within 7 days of the deposit of the initial amount. In case she / he fails to make deposit of the total amount as per the bid within the stipulated time, the deposit including the earnest money shall be forfeited.

5. The successful bidder shall take permission and remove the vehicle from the Raj Bhavan premises within two days of deposit of the total bid amount. On failure to remove the vehicle within the aforesaid time, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicles from the Raj Bhavan premises. If the ground rent so charged exceeds the sale price deposited, then the bidder shall cease to have any right on the vehicles and the amount deposited by her / him shall be adjusted towards the ground rent.

6. The authority reserves the right to reject any or all the bids without assigning any reason thereof.
